## MEMORANDUM CIRCULAR

To: All Presidents & Treasurers of Component, Specialty Divisions, Specialty and Affiliate Societies

Re: **May 31, 2010: Deadline of extension  
of the 50 % Discount on all arrears**

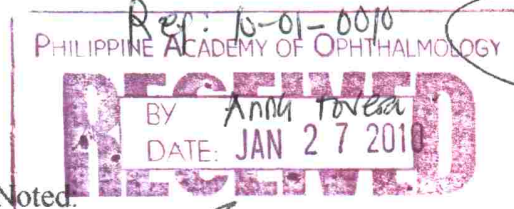
Please be informed that the grant of extension of the 50% discount to all members to settle their arrears on membership dues from 2007 and earlier years will be up to **May 31, 2010 only**. However, membership dues for 2008 and 2009 are **to be paid in full**. All component societies are therefore requested to inform all concern and to extend the same privilege to their respective members and to facilitate, as well, the settlement of said obligation before the aforementioned deadline.

The benefits accorded to members in good standing, specifically the right to vote and voted upon, however, shall be restored one year after reinstatement as an active member. The Mutual Aid Code further provides that the reinstated member shall receive mutual aid benefits as follows:

- Within the 1<sup>st</sup> year of enrollment no benefits
- Within the 2<sup>nd</sup> year of enrollment, 25%
- Within the 3<sup>rd</sup> year of enrollment, 50%
- Within the 4<sup>th</sup> year of enrollment, 75%
- Fifth year and beyond, 100%

This privilege is being extended to all members preparation for the integration of the Philippine Medical Association.
